Pandemic Legal is organized exclusively for charitable purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

The purpose of Pandemic Legal is to deliver free and reduced-cost legal services to Americans affected by the coronavirus pandemic.

Pandemic Legal is supervised or controlled in connection with Pandemic Patients (EIN: 69-3930257) by placing management with the same persons that control or manage Pandemic Patients.

Pandemic Legal is organized and at all times operated exclusively for the benefit of Pandemic Patients. Pandemic Legal shall not carry on any other activities not to be permitted to be carried on by Pandemic Patients.

Pandemic Legal’s Board of Directors shall have three members, the majority of which must be currently serving as Directors on the Pandemic Patients Board of Directors.

The Pandemic Patients Board of Directors may appoint and remove Directors from the Pandemic Legal Board of Directors at any time and without cause.

The Pandemic Patients Board of Directors shall review and approve any proposed changes to the Pandemic Legal Corporate Bylaws.

Upon dissolution of Pandemic Legal, assets shall be distributed to Pandemic Patients. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
